2 Apologies For Absence and Declarations of Interest

There were 2 apologies for absence. Elizabeth Robinson proposed and Matt Price seconded that the minutes of the Meeting held on 8th July 2009 were a true account. The minutes were signed by the Chairman.

3 Matters Arising

HWRC meeting delayed until (October) Clerk to write to Chief Executive of May Gurney to convey the Parish Council's appreciation of the work that May Gurney and their team put in at the Bergh Apton site.

4 Public Consultation

3 members of the public spoke about the proposed local needs affordable housing for Bergh Apton please see below

5 Local Needs Affordable Housing

The Chairman reported that there had been 34 visitors to the public consultation event which had taken place this afternoon/evening. There was overwhelming support for the principle of affordable housing for local people only. At the Parish Council meeting following the event, concerns were raised about whether this was the right choice of site and had another brownfield site ie. the brickworks been considered, concern about the road junction and a question was raised whether there was a need for any housing at all and that this scheme was ruining a nice part of the village. Questions were raised about the procedure and whether the matter would be subject to a full planning application in due course.

Derek Blake Cabinet Member of Planning for South Norfolk said that in the Local Development Framework (LDR) there may be some small developments in the next 40 years during the life of this framework but this scheme in no way set a precedent. He said that geographically this piece of land is at the centre of the village alongside the village sign. Cllr Adrian Gunson said that the proposed plans were a good design and he supported the proposal. He added that private land could only be used if it was offered and that many areas of the village are without services, like drainage and sewage which would cost too much to install.

In response, John Fuller, leader of South Norfolk, stated that Saffron Housing would be applying for planning permission in due course and this would go to a planning committee and members of the public would be able to have their say. He said a number of sites had been considered, one was withdrawn and many landowners had been written to also asking whether they could offer their land for affordable housing. The professional planners had recommended that this site on Church Road by the Village sign was the best. Mr Fuller reminded everyone that the housing waiting list had increased by 50% to 4,500 in the last 18 months and that the council had been elected on a manifesto commitment to provide a 'handful' of affordable homes reserved for local people in every village.
