The Household Waste Recycling Centre, Bergh Apton

As Clerk of Bergh Apton Parish Council I have been asked to contact you regarding the expiration of the planning consent for Bergh Apton HWRC in Welbeck Road, in 2012 and to convey the views of both the Parish and Parish Council.

At a public meeting with the Parish Council on 1st December 15 people came to give their opinions. The feeling of the meeting was that the planning consent should not be renewed. Many of those attending live close to the site and made the following points

- The site is physically remote from the main road network and light vehicle traffic, especially at weekends on the village roads, reduces local residents' enjoyment of their gardens

- Heavy Traffic is then generated whilst the waste is removed in the early part of the following week. There are issues of road safety and the ability of the road to support this traffic.
- The site is well run and has high recycling rates but not all waste is accepted, which creates fly tipping.
- Those residents most affected were 'promised' some years ago that the site would close in 2012 and are now dismayed that an extension is being considered.
- The HWRC facility in the neighbourhood is welcomed but it would be better closer to the main roads.

The Parish Council has taken full account of the objections of those living nearby, recognising that it has been the source of long-standing inconvenience to immediate neighbours. But it is also considered that:

- The presence of the site in Bergh Apton is an amenity to other local residents in Bergh Apton and elsewhere, especially considering the long distance that would have to be travelled to alternative facilities if it closed.
- This might generate more flytipping if people didn't wish to travel to other sites.
- The site is now open on only 4 days per week and the hours are limited. So, in theory, the impact on local residents is now less than before.
- As a Parish Council we are very concerned about what alternative use there might be for this site if it were to close.
- The site is well run and gives local residents the chance to recycle their household waste. The site is consistently the highest performing site in Norfolk for recycling. If it were to close, recycling rates would fall.

The Council feels that it should place both sides of the argument in front of the District & County Council so that it might make a fully informed decision about renewal in due course.

The Parish Council is mindful that the immediate neighbours are seriously inconvenienced but that residents further away consider the site to be an amenity which they would miss if it closed.
