1. To receive apologies for absence and Declarations of Interest. **Apologies received from: Lord Fuller, Martin Graystone, Hugh Porter**
2. To approve the Minutes of the Parish Council meeting held on 7th January 2026.

3. Presentation of County Councillor Kay Mason-Billig and/or District Councillor John Fuller: Parish Report of Kay Mason Billig received on 13th January 2026 and circulated to Parish Council. Not specific to Bergh Apton. **Noted: General Report received from Lord Fuller regarding planning, Council re-organisation and other matters circulated to the Parish Councillors. This report contained a link with comprehensive discussions taking place in the House of Lords. Lord fuller advising the Consultation on Village Clusters finalised. He suggests that if the Village has any important matters needing recognition that the time to propose those would be when planning applications are made. (eg speed limits in the Village). It is clear that Lord Fuller is working hard to represent the interests of small rural communities in difficult circumstances. ACTION: Clerk to write and thank John Fuller for his advices and his representations made for us as a rural community.**

5. To report progress on items on the agenda arising from the last meeting (Clerk's Report):

- (i) Progress on bus shelter lighting works following request of installers to adjust the sensors. Damage to Bus Shelter and proposals for vandalism avoidance following damage. Police advised of damage. **Sue Price has contacted Redhill concerning the sensors being adjusted and Redhill will inspect. As to the**

vandalism to the front panels of the bus shelter the Parish Council feel there is no merit in replacing these as damage can be repeated. The Council feel the main purpose of the shelter is to keep people dry which the roof does. **ACTION:** Guy Warde-Aldam will inspect and report back.

- (ii) Progress on Signage for Play Area and revised invoice. **Sue Price presented the sign for the play area which the Council are very happy with. ACTION: Sue Price to establish who will assist with the installation.**

6. Progress on repairs to the rocks on the play equipment by Martin Graystone. **The position of the replacement rocks will need moving as the “wall” to which they are to be attached is not sufficiently robust for the addition of new rocks. ACTION: Sue Price to discuss with Martin Graystone**

7. Lectern Works: Consideration of the finishing painting as per John Ling’s email to the Parish Council of the 23rd February 2026 and circulated to the Council on 24th February concerning options and costings. **John Ling attended the meeting to ensure that the Parish Council are happy with the price increases for the lectern work for matters such as powder coating. The Parish Council feel that this work should be undertaken to the best standard as it will be more economic in the long run. John Ling presented costings to the Council and the increase in cost is £59.00 John Ling suggesting a ceremony in May time to celebrate the installation of the Lecterns. Both additional costings and installation ceremony agreed by the Parish Council.**

11. Targeting introduction of 30 MPH on the Street – Update on Steering committee and next steps. Steps taken regarding the suggestion of seeking assistance from Kevin Allen Safety Officer for Highways at Norfolk County Council. **Kevin Allen contacted regarding advice re: additional safety measures that would aid all road users within Bergh Apton. Sue Price has been informed that this request will be dealt with by both Kevin Allen and Gary Overland. She is awaiting a reply.**

Document uploaded to website 3rd February following inability to secure further information. Confirmation of this upload from Steve Whitby confirmed by email, which email was circulated to Parish Councillors 4th February 2026. **Sue Price signed the hard copy.**

15. Thurton Parish Council discussions regarding Bus Shelters at Prospect Place update. **Both Thurton and Bergh Apton Parish Councils decided not to progress this as it is not considered not a good use of public money.**

16. Concerns in the Village regarding speeding tractors with trailers and other farm equipment and mud/other debris on the roads. **Sue Price has spoken with the person farming land in the village who has contacted the contractors driving the tractors and machinery through the village to ask drivers to slow down and be respectful of speed in the village and exercise care. Mud on Dodgers Lane was cleared by the farmer. Rain washed mud away on the other less affected roads. Duck manure debris on the roads was pointed out and it was confirmed that the contractor would be notified of this and asked to not excessively load the trailers in the future. The footpath from Dodgers Lane across the field where the vehicles exercised entry on the fields with the duck manure is severely damaged and there are deep ruts causing concern to people using that right of way who could fall/lose their footings and injure themselves. The farmer confirmed the right of way would be made good once the land has dried out, likely to be April/May time. The moving of duck manure is time sensitive and happens only once a year. It is usually in the Autumn not winter as this year. We would like to thank the farmer for taking the time, consideration and action regarding these matters.**

17. Repairs to SAM 2 equipment and costings. **Mike Rimmer is attending Westcote to deal with any repairs and invoices awaited.**

18. Odour from ditch at corner of Dodgers Lane and the fields. **ACTION: Clerk to email an owner of one of the properties using the Klargestor discharging onto this land to see if they are aware of the problem and if the matter can be rectified.**

19. SNDC Litter Pick Scheme. **The Parish Council feel the litter is being collected on a regular basis throughout the year.**

20. Finance: Accounts Reconciled and Reconciliation Statements circulated to Parish Councillors. Payments:
